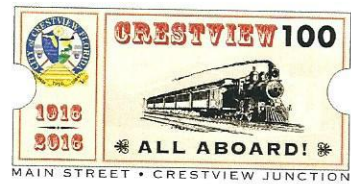

There will be a costume contest for groups and individuals up to age 16 with a Pet Costume Contest and Parade too! Fees vary depending on the nature of your booth (see below). Participants may distribute materials to promote their cause (pamphlets, business cards, etc.) If the event is rained out, there will be no refunds, and there is no current plans for a rained-out date. All payments received by Main Street Crestview will go to support the Associations' various downtown revitalization efforts. Fundraiser by Non-Profits 501c(3) form required.

- Food Vendors are asked to be checked-in by 12:00pm and set up by 1:00pm
- ALL BOOTHS must be set up by 1pm, when the festival begins. We request that booths remain open until 6pm.
- A map and directions of the event location will be e-mailed prior to the event.
